Forfar Education is a group of independent schools around the UK with aspirations to achieve further growth, both in the UK and internationally. Having recently acquired and added new schools to its expanding portfolio, the team at Forfar found that each school had different IT and cybersecurity technology and varying levels of cyber protection. Some of the technology had become outdated and presented a potential risk to data security.

The leadership team therefore made cybersecurity a key priority in order to meet child safeguarding obligations and protect data. However, with budget constraints and only a small internal team to manage IT across the entire group, Forfar set out to find a solution that could serve all of its schools' security protection needs, while being easy to manage centrally. #### **Business challenges**

As an independent education provider, with establishments ranging from nurseries to primary to secondary schools, Forfar Education is bound by a duty of care to its students and their parents, and the 350 staff who work there. With obligations around child safeguarding and data protection, together with combatting the increasing risk and complexity of cyber-attacks in education, Forfar Education identified cybersecurity and access control as a strategic priority.

As a group of nine schools across the UK, some of which were recently acquired, Forfar Education found the existing IT and cyber security technology to be of varying quality, so it needed a coherent, consistent and comprehensive solution to improve and standardise the security posture of every school in the group. With budget constraints and a small IT team with limited capacity to manage cyber threats around the clock, Forfar required a solution that could be easily managed centrally and provide the peace of mind that students, staff and data were properly protected. Additionally, as Forfar has ambitions to expand further, both within the UK and internationally, the solution would need to be easily implemented across any new schools acquired by the group, either within the UK or abroad.

Al Butler, IT Director at Forfar Education, joined the group in 2021, and having extensive knowledge previously of running his own IT services business, knew that a substantial overhaul of the cybersecurity infrastructure was required. Forfar would have to completely upgrade and consolidate its firewalls across all sites and integrate solutions
